NOTICE IS FURTHER GIVEN THAT at such meeting the Board of the District intends to make a final determination to issue or make amendments with respect to general obligation indebtedness consisting of the pledge of property tax revenues (pursuant to multiple capital pledge agreements) for the repayment of indebtedness by the Painted Prairie Public Improvement Authority (the “**Authority**”) consisting of the Authority’s Taxable Subordinate Special Revenue Bonds, Series 2019B, in the maximum principal amount of \$150,000,000, which amount is subject to increase or decrease as determined by the Authority Board, or as otherwise permitted by any resolution adopted by the Authority Board at such meeting, and, in connection therewith, the District Board will consider a resolution: authorizing the issuance of such indebtedness; approving, ratifying and confirming the execution of certain documents; making determinations and findings as to other matters related to such financing transaction; authorizing incidental action; and repealing prior inconsistent actions.

NOTICE IS FURTHER GIVEN THAT pursuant to the Supplemental Public Securities Act, no legal or equitable action brought with respect to any legislative acts or proceedings in connection with the authorization or issuance of such bonds may be commenced more than thirty days after the authorization of such bonds pursuant to the aforementioned resolution.

The Board will also take up such other business as may come before the Board. The meeting is open to the public.

Pursuant to the provisions of the Supplemental Public Securities Act, one or more members of the Board may participate in this meeting and may vote on the foregoing matters through the use of a conference telephone or other telecommunications device. There will be at least one person present at the physical location posted on this notice.

This notice is given by order of the Board of the District, and shall be posted on the District’s website, not less than 24 hours prior to the meeting.
